Chair Sekaquaptewa thanked everyone for joining the Special CNMC meeting. She appreciated the quorum, and the number of other guests who joined the special meeting.

Chair Sekaquaptewa reminded the group about the Broadband day at the Legislative session and acknowledged the appearance by Governor Michelle Lujan Grisham. Several members of the broadband and internet services joined the CNMC meeting on this day, and she mentioned it was helpful to have so many subject matter experts gathered.

3.5 AWARD ANNOUNCEMENT FOR TULAROSA COMMUNICATIONS- on

recording at 0:17:31

Director Kelly Schlegel of Office of Broadband Access and Expansion introduced the team from Tularosa communications who just received a grant award from the Connect New Mexico Pilot Program to connect 1,100 homes. It will connect people who never had internet access before.

3.6 OFF AGENDA EVENT ANNOUNCMENT

Scott Lopez, VP of business development and government affairs at Kelly Cable. They do turnkey work for fiber networks. Kelly Cable hosting an event Monday. USDA is hosting a DC delegation in ABQ to recognize companies of NMECG who are getting \$40 million in reconnect grants.

4. RULEMAKING—KIMBAL SEKAQUAPTEWA, MELISSA GUITERREZ

Updated rule shared with the Council, with feedback and reviews.

-Ms. Gutierrez offered an update: We are ready to adopt the rules. We will not make the April 1st effective date.

-Will get them to the administrative office, and if they are adopted today, they can become effective after they are published which is 15 days after tomorrow.

-Rule hearing was on January 31st, followed by a 10-day response period, and a hearing officer issued a recommended decision. The decision was issued by Brian Brock on March 1st.

- A final order drafted in a word document, which is what needs to be discussed for adoption.

-Ms. Sekaquaptewa noted two sections of the document are missing the key demographic of veteran. The Chair also noted that she was expecting to read language respecting Tribal Sovereignty or the New Mexico Tribal State Collaboration Act, she's wondering if there is a chance to add those to the NOFO. (Ms. Gutierrez mentions that doesn't necessarily need to be in the rules.) Mr. Enjady asked about the possibility of an amendment after approving the rules. Ms. Gutierrez answered that pursuant to the rules act you can make an amendment, and only publish portions, we can adopt as is now, and come back to the table with the amendments and start the process over to only address the issues. Mr. Viorica mentioned he is supportive of moving forward with the rules the way they are as people are anxiously waiting to have a framework in place that will allow projects and grants applications to be developed.

-The changes: April 1st to April 11th

- on recording at 0:40:00 Ovidiu Viorica makes a motion to adopt the rules as written, to allow the OBAE to start writing NOFO, to put money to work as soon as possible. Katherine Crociata 2nd. No opposition. Motion passes.

- Took 7 Broadband bills through the legislative session 6 passed.

- 1 did not pass, HB213 SJC, back logged, many bills got stopped there, and

died.

- HB155, takes PRC fund in 2026 converts \$30 m fund to broadband
- HB362 amends HB10 which is the OBAE Act
- HB262 amends the Connect New Mexico Act
- SB452 old sb 93 passed within 24 hours.
- SB41 levels playing field- 'the lumen bill'
- HB160 Rights of Way
