Welcomed the group to the meeting. And offered insights on current work being done.

- President of CTC technology, contractor for OBAE, here to help with developing analytics data and developing the multiple critical plans that are required of the state to submit to NTIA in order to access funds.
- We have a number of years of experience with working with communities and stakeholders throughout New Mexico and really excited to continue with these relationships.
- Introduction of the Senior CTC team.
- The engagement process is a multi-phase process. Initial engagement->ongoing monthly touchpoints->Public comment & formal stakeholder feedback process.
- Three critical plans are due between now and the end of the year. The 5-year action plan, Digital equity plan and the initial proposal.
- Godfrey/Kimball: comments about Tribal working group working with Tribes now and making sure there isn't duplicative work. The tribal working group can help CTC.

Godfrey: Tribal Working Group update: working hard to engage.

-Had opportunities to visit many pueblos in Arizona.

-Discussed the grant itself on the TCBP.

-Looking at issues for sustainability, start up funding. USDA released information about new funding in a grant.

-Vendors talk about equipment available today. But when funding is out, there will be fewer parts. A requirement to get the funding buying American, and not much is made here. Can we get relief on that, by asking congress?

-Mapping is moving great. However, it will be cumbersome for FCC to make changes. There are examples of connectivity going into a shack where there is no connectivity.

Eli Guinnee: Co-chair digital equity with Catherine Nicolaou,

-Meets every other week. There are schedule conflicts, until May 18th.

-Team presenting at UNM tech days.

-In the coming months they will get more of the work down on paper. Starting with digital equities priorities, and a matrix that ties to the NOFO.

-State libraries is leading a digital equities task force which just released a survey to libraries. It will be open until May 15.

• Catherine **Co-chair digital equity**: CTC will be able to tap into a wealth of knowledge from the working group.

-There is an opportunity for CTC to guide NM on how to track some of the

information in terms of the organizations/the knowledge. What has worked, what hasn't.

Jerry Smith: Regional projects group.
