

CYBERSECURITY WORKFORCE DEVELOPMENT PROJECT

REQUEST FOR QUOTES

(THIS IS A FEDERALLY FUNDED PROJECT)

1. Background:

The U.S. Department of Homeland Security provides funding through the State and Local Cybersecurity Grant Program (SLCGP) to address cybersecurity risks and threats to information systems of participating State, Local, and Tribal governmental bodies and K-12 and Higher Education Institutions. The State of New Mexico SLCGP Cybersecurity Planning Committee (Planning Committee) developed a Statewide Cybersecurity Plan, which included a cybersecurity capabilities assessment to form an initial understanding of the cybersecurity posture across New Mexico. Based on the assessment results, the Planning Committee identified and approved five initial cybersecurity projects to address cybersecurity gaps leveraging SLCGP funding. Those projects include Cybersecurity Governance and Planning, Cybersecurity Risk Assessment, Vulnerability and Attack Surface Management, Cybersecurity Training, and Cybersecurity Workforce Development Planning. The Planning Committee has coordinated with the New Mexico Office of Cybersecurity to implement and provide cybersecurity projects as services to participating entities.

2. Introduction and Purpose:

The New Mexico Office of Cybersecurity is seeking quotes from qualified Contractors to provide comprehensive strategic planning, development, implementation and support services for the Cybersecurity Workforce Development initiative under the SLCGP. This initiative aims to enhance the cybersecurity capacity of State, Local and Tribal governments and K-12 and Higher Education Institutions in the State of New Mexico. Participants in the project include 4 Local government entities, 10 County government entities, 1 Tribal government entity, 1 K-12 Educational Institution, and 3 Higher Education Institutions (participating entities). The Contractor will use the National Initiative for Cybersecurity Education (NICE) Framework to identify and assess gaps in the cybersecurity workforces of the participating entities, strengthen recruitment and retention efforts for those workforces, and bolster the knowledge, skills, and abilities (KSAs) of the cybersecurity personnel in the participating entities.

3. Contractor Requirements:

A. Contractor must be a current awardee under one of the following procurement methods:

- New Mexico Statewide Price Agreement (SWPA)
- Federal GSA Schedule Pricing
- NASPO ValuePoint Pricing Schedule

4. Scope:

The Contractor will deliver services on a time and materials basis to support the following activities:

Phase I - May 1, 2025 – November 30, 2025

A. Strategic Project Planning -

A.1 - Needs Assessment

- In consultation with the Office of Cybersecurity, conduct stakeholder interviews and surveys with participating entities to identify existing workforce gaps and challenges.
- Map the current state of the participating entities' cybersecurity roles and positions, cybersecurity workforce recruitment and retention practices, cybersecurity workforce KSAs, and cybersecurity workforce training and development against the NICE Cybersecurity Workforce Framework.
- Deliver a gap analysis report identifying workforce needs, vulnerabilities, and training deficiencies.

A.2 - Workforce Development Strategy

- Develop a detailed roadmap to address identified gaps, including short-term and long-term goals for recruitment, retention, and skill development.
- Create tailored strategies for participating entities.

A.3 - Phase Completion Report

- Deliver final report to the Office of Cybersecurity on Phase I activities and results.

Phase II – January 2026

B. Implementation and Support

B.1 - Implementation

- Oversee the rollout of workforce development initiatives in consultation with the Office of Cybersecurity and in coordination with participating entities.
- Facilitate virtual introductory sessions with the participating entities.

B.2 Support Services

- Offer ongoing technical and programmatic support to participating entities.
- Maintain a helpdesk to assist participating entities with program-related issues.

C. Workforce Recruitment and Retention Enhancement

C.1 - Recruitment Strategies

- Develop outreach programs to attract quality candidates to the cybersecurity workforce.
- Collaborate with participating entities to establish internship and apprenticeship programs.

C.2 - Retention Programs

- Design retention frameworks, including career progression plans, incentive programs, and professional development opportunities.
- Provide recommendations for fostering workplace environments conducive to long-term employee retention.

D. Knowledge, Skills, and Abilities (KSAs) Enhancement

D.1 - Training Program Development

- Design customized cybersecurity workforce professional development training modules aligned with the NICE Cybersecurity Workforce Framework.
- Create skill-based certifications and credentials specific to the needs of New Mexico's governmental and educational entities.

D.2 - Training Delivery and Support

- Develop an online learning platform and offer virtual training sessions to include cybersecurity courses, interactive exercises, games, and non-cyber executive skill development.
- Provide technical support and instructional materials for participants.

D.3 - Evaluation and Metrics

- Establish evaluation criteria and performance metrics to measure the success of training programs.
- Deliver periodic reports on training outcomes, workforce improvements, and KSA enhancement.

D.4 - Phase Completion Report

- Deliver final report to the Office of Cybersecurity on Phase II activities and results.

5. Quote Requirements:

Interested Contractors must submit the following:

- Executive summary of qualifications and relevant experience.
- Detailed approach to the Scope of Work, including timelines and methodologies.
- Key Personnel resumes and certifications.
- Sample deliverables from similar projects.
- Minimum of three references from similar projects to be completed on the web-based Reference Questionnaire Form found at <https://forms.office.com/g/9jYJdfh82>.
- Cost Response Form based on time and materials (See Attachment “B”).
- Fully executed copies of the required Federal Forms (See Attachment “A”) for Suspension and/or Debarment Certification and Anti-Lobbying Certification.

6. Evaluation Criteria:

Quotes will be evaluated based on:

- Technical expertise and relevant experience (30%).
- Quality and feasibility of proposed approach (30%).
- Cost efficiency and value (20%).
- Past performance and references (10%).
- Compliance with submission requirements (10%).

Questions and Quotes must be submitted electronically by the deadlines outlined in Paragraph 8. 9. Anticipated Contract Term:

It is anticipated that the Term of a Contract awarding Phase I of the Scope of Work will commence on or around May 1, 2025, with the work completed by November 30, 2025. It is anticipated that Phase II of the Scope of Work will be awarded by amendment following November 30, 2025, with the contract expiration date mutually agreed upon between the parties. In accordance with NMSA 1978, § 13-1-150, no contract term for a professional services contract, including extensions and renewals, shall exceed four years, except as set forth in NMSA 1978, § 13-1-150. Nothing in this Request for Quotes guarantees award of any contract. Execution of a Contract or Contract Amendment is dependent upon the Federal and/or State government providing adequate funding to proceed with the Project.

INSTRUCTIONS FOR SUSPENSION AND/OR DEBARMENT CERTIFICATION

1. By signing and submitting this form, the prospective lower-tier participant is providing the certification set out on the previous page in accordance with these instructions.
2. The certification in this clause is a material representation of fact upon which reliance was placed when this transaction was entered into. If it is later determined that the prospective lower-tier participant knowingly rendered an erroneous certification, in addition to other remedies available to the Federal government, the department or agency with which this transaction originated may pursue available remedies, including suspension and/or debarment.
3. The prospective lower-tier participant shall provide immediate written notice to the person to whom this proposal is submitted if at any time the prospective lower-tier participant learns that its certification was erroneous when submitted or has become erroneous by reason of changed circumstances.
4.
