Service Highlight:

What is an Employer of Record?

An Employer of Record (EOR) is the individual responsible for directing the work of Mi Via employees and vendors for Mi Via participants. The EOR is not paid. An EOR is the common law employer of workers who provide waiver services.

The EOR is responsible for:

- Finding Qualified Employees
- Finding Qualified Vendors. A Vendor can be a DOH approved provider or
- another agency that provides the service that you are looking for.

- Hiring Employees
- Setting Employee Pay Rates
- Training Employees and Vendors in accordance with Mi Via Service Standards.
- Setting Employee Work Schedules
- Approving Employee Timesheets and Vendor Payments

Although the EOR is an unpaid role, the EOR plays an important role in ensuring that the Mi Via participant gets their services and goods.

Who can be an EOR?

- A Mi Via participant may be his or her own EOR unless the eligible participant is a minor or has an authorized representative (i.e. guardian) over financial matters in place.
- If the participant is not their own EOR, the EOR must be a legal representative of the recipient
- The EOR should be someone who knows the participant, is aware of the participant's supports needs, and has an interest in ensuring that the participant gets their services and goods.

Persons interested in becoming an EOR must complete the Employer of Record packet to establish themselves as the EOR and to use the Federal Management Agency (FMA) for payroll and other employment related functions.



Demand Notices

- The New Mexico Department of Workforce Solutions (WFS) sends Demand Notices to Employees who do not send a quarterly wage report.
- The Demand Letter means that your EOR and Wage Detail Report for the quarter is due
- If you receive a Demand Notice, please send the letter to Conduent via fax, email or mail.

- Palco will review and make all necessary corrections to stop demand letters.
- Palco will file the Wage Detail Report and make any appropriate payments.

Coming soon

- Gross Receipt Tax (GRT) Outside the Budget:
 - GRT is currently included in the cost of services for Mi Via participants. By rmoving the cost of the GRT outside of the Individual Budgetary Allotment (IBA) participants will have more money available to spend on purchasing services.
- Individual Budgetary Allotment (IBA) Increase:
 - IBA amounts are being increased to accommodate increased rates that have occurred over the last few years. An implementation plan and instructions are being

- developed and will be shared before July 1, 2024
- Vendor Access to FOCoSonline:
 - Human Services Department (HSD) is working with Conduent to give vendors access to FOCoSonline. Vendors will be able to submit billing within FOCoSonline removing the need to submit paper invoices. Request Forms (VPRs), run vendor-related reports, and monitor vendor billing. Training and more information on this to follow.
- As of July 1st of 2024, the Human Service Department (HSD) and the Department of Health (DOH) will be known as the Health Care Authority (HCA).

Employment Separation Notice Requirement

Employer of Record is required to notify Palco of separation of employment when:

- An employee quits
- An employee is let go
- An employee is no longer providing any services for a participant.

Failure to notify Palco can:

- Risk fraudulent claims filed against the participant's budget.
- · False unemployment claims.

Always submit the employee separation form to Conduent as soon as possible to avoid the above issues.

Rise and Shine Parfait
