    - DDSD thanked those who have provided feedback on the Mi Via Service and Support Plan.
    - During the Centers for Medicare & Medicaid Services (CMS) site visit in September 2024, it was recommended that the Developmental Disabilities Supports Division (DDSD) create a process allowing for

- appropriate sharing of Service and Support Plan information with all involved vendor providers.
- As part of ongoing efforts to enhance coordination and transparency within the Mi Via program, input is requested regarding the development of a process to share complete Service and Support Plans with all approved vendor providers. Input is essential in guiding the design of a process that respects participant autonomy and confidentiality while strengthening provider collaboration.
  - When asked, Elaine ensured that Mi Via constituents had the information needed to provide feedback on the changes.
