Subject: Allocation Plan

The Developmental Disabilities Supports Division is thrilled and deeply grateful for the funding allocated by the legislature in House Bill 2 to have a "No Wait List" policy for home and community-based

services (HCBS) waivers.

Beginning August 15, 2025, the allocation process, formerly occurring annually, will become a monthly allocation offering. The first group of 245 individuals currently on the waitlist will receive allocation letters in August. Thereafter, the DDSD will issue monthly allocation offer letters on the 15th of each month, with an expected volume of 50-60 offers per month, based on historical data regarding application rates.

Monthly allocations support timely access to services and supports for all New Mexicans with intellectual and developmental disabilities who meet the eligibility criteria.
