Voter Registration Cancellation Request Form

Instructions

1-4-30 NMSA 1978 provides that the county clerk shall cancel a certificate of voter registration upon the request of a voter only for the following reasons (1) when the voter changes the voter's registered residence to another county within the state; (2) when the voter moves to another state; or (3) upon the written request of the voter.

<u>If you have moved to another county within the state:</u> You can update your voter registration by submitting a new voter registration form with your new address. The county clerk in your new county of residence will transfer your voter registration to your new county.

If you have permanently moved to another state, you are no longer eligible to vote in New Mexico: You can request that your voter registration be cancelled using this form.

<u>If you wish to cancel your voter registration for any other reason:</u> You may cancel your voter registration using this form.

After completing this form, mail it to the New Mexico Secretary of State, 325 Don Gaspar, Suite 300, Santa Fe, New Mexico 87501, or the county clerk in the county in which you are registered.
