**Requirements and Instructions for Amending
a New Mexico Marketing Cooperative Association
(76-12-9 NMSA 1978)**

Filing Fees: \$25. Please make the check or money order payable to New Mexico Secretary of State or

NMSOS. **Filing:** The incorporators of the association shall file with the Secretary of State:

1. Articles of Amendment drawn up based on the below statute, 76-12-9 NMSA 1978 and signed by two officers of the association.
2. A check or money order in the amount of \$25.00 made payable to NMSOS.

Please refer to the New Mexico Cooperative Marketing Associations Act 76-12-1 to 76-12-23 NMSA 1978 for the complete statutes governing a Marketing Cooperative Association. The Business Services Division can only act in an administrative capacity. We cannot offer you legal advice or opinion on your particular filing. We recommend that you consult with your own attorney and accountant during the process of incorporating as an association.

76-12-9. Amendments to articles of incorporation

The articles of incorporation may be altered or amended at any regular meeting or any special meeting called for that purpose. An amendment must first be approved by two-thirds of [the] directors, and then adopted by a vote representing two-thirds of all members present at such meeting. Amendments to the articles of incorporation when adopted shall be filed in the same manner as provided for the filing of the original articles.
