This form may only be used by a registrant of a trademark/service mark who seeks to renew a registration. If the mark has been changed or if the kind of goods or services is expanded from that set forth in the original registration application, you must submit a new Application for Registration.

Enclose **one** specimen of the mark. This must be an actual specimen that is being used in commerce.
