

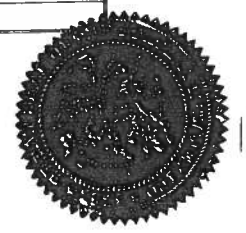
Canvass of Returns of General Election Held on November 8, 1994 - State of New Mexico
