INDEPENDENT ACCOUNTANT'S REPORT ON APPLYING AGREED-UPON PROCEDURES

We have performed the procedures enumerated below, which were agreed to by the State of New Mexico, Secretary of State, solely to assist you in evaluating the accuracy of voting system machine tabulators used in the conduct of the 2012 general election held on November 6, 2012. This agreed-upon procedures engagement was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants. The sufficiency of these procedures is solely the responsibility of those parties specified in this report. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.

Section 1-14-13.2 NMSA 1978 and 1.10.23.9A NMAC requires a voting system check for all federal offices, the office of the governor and the statewide elective office, other than the office of the governor, for which the winning candidate won by the smallest percentage margin of all candidates for statewide office in New Mexico. If any of the contests resulted in a winning percent margin greater than fifteen percent (15%), a voting system check in that contest is not required. The 2012 general election did not include a contest for the office of the governor. The winning percent margin in all of the United States Representative contests was greater than fifteen percent (15%). Therefore, we performed the procedures enumerated below for (1) President of the United States, (2) United States Senator and (3) New Mexico Justice of the Supreme Court.

Our procedures and findings were as follows:

VOTING SYSTEM CHECK

1. Selection of precincts for the voting system check.

Procedure - A list of all voting precincts in the State of New Mexico showing total registered voters for each precinct was obtained from the Office of Secretary of State. A spreadsheet showing the voting precinct, congressional district, total registered voters for each precinct and a cumulative number of registered voters beginning alphabetically with the first Bernalillo County precinct, and ending with the last Valencia County precinct was developed. The county-reported election results were obtained from the Office of the Secretary of State. The required sample of precincts to be tested as provided pursuant to Section 1-14-13.2(B), was randomly selected using a "dice roll" method whereby seven ten-sided dice were rolled and the resulting number normalized so that a particular voter (un-named) could be identified within all the voting precincts in the state. A total of 13 rolls of the dice were needed to select the required number of precincts to be tested.

An analysis of the reported election results determined that six (6) precincts be selected for President of the United States, six (6) precincts for United States Senator, and thirteen (13) precincts for Justice of the Supreme Court (the statewide office with the smallest winning margin). (See Appendix A-1). A public meeting was held in room 317 in the State Capitol Building at 9:00 a.m. on November 14, 2012, to select the precincts to be included in the voting system check. A copy of the instrument used to capture the selected precincts is included in Appendix A-3 of this report.



VOTING SYSTEM CHECK (Cont'd)

2. Notification of county clerks of the precincts selected for the voting system check.

Procedure - We notified each county clerk of the precincts which were selected within their county that would be subjected to a hand recount. We also provided the methods for reporting the recount back to the auditors and provided tally sheets to be used by the county clerks to report the hand recount. (See Appendix A-2).

3. Receipt of hand recounts from the affected counties.

Procedure - We received hand recount results from the appropriate counties.

Most results were e-mailed to us by the county clerks. A few were sent to us via U.S. mail, and a few others were mailed to the Office of the Secretary of State, who then forwarded them to us.

Finding - All counties selected for the voting system check provided us with hand recounts for the precinct and races selected.

4. Analysis of the results of the hand recounts.

Procedure - As the results of the hand recounts were provided to us from the counties, we recorded the results for each precinct separately for election day voting, early in-person voting, and absentee by mail voting. We recorded the voting machine tabulator results for each precinct separately for election day voting, early in-person voting, and absentee by mail voting. We obtained the voting machine tabulator results from each affected county's canvass reported to the Office of the Secretary of State. We accumulated the results for all affected counties and precincts by contest and analyzed the differences between the hand recounts and voting machine tabulator counts.

Finding - We found that there were differences in hand recounts and voting machine tabulator counts resulting in error rates of 0.151% for the President of the United States contest, 0.116% for the United States Senator contest, and 0.213% for the Justice of the Supreme Court contest. The reason(s) for the errors cannot be determined, but must result from either incorrect canvass reporting to the Office of the Secretary of State, or errors in the actual hand recounts provided to us by the affected counties. The error rates are considered to be acceptable. A copy of the analysis is included in Appendix B to this report.

5. Determination of whether additional hand counts are required.

Procedure - We analyzed the results of the hand recounts and voting machine tabulator counts to determine whether further hand recounts were necessary as required by Section 1-14-13.2D NMSA 1978 and 1.10.23.9A(3) NMAC.

Finding - Section 1-14-13.2D requires a hand recount of additional precincts for an office if the error rate determined from the original hand recounts is greater than ninety percent of the reported voting machine tabulator contest margin. The analysis included in Appendix B to this report shows that the error rate did not exceed the ninety percent test in any of the contests audited. Therefore, no additional recounts are required.

Other Matters Noted

Included in Appendix C to this report are documents that report the results of the voting system check by precinct and mode of voting. In addition, the voting system check results for Bernalillo County are reported by voting convenience center.

We were not engaged to and did not perform an examination, the objective of which would be the expression of an opinion on the accuracy of voting system machine tabulators used in the conduct of the 2012 general election held on November 6, 2012. Accordingly, we do not express such an opinion. Had we performed additional procedures, other matters might have come to our attention that would have been reported to you.

This report is intended solely for the use of the State of New Mexico, Secretary of State, and should not be used by those who have not agreed to the procedures and taken responsibility for the sufficiency of the procedures for their purposes.
