

Campaign Finance Random Examination Report – 2016 Election Cycle

June 7, 2017

Introduction

Due to the current influence of money in American politics, it is important for states to have robust and transparent laws that require candidates, campaigns and political committees to report their campaign-related financial activities within the state. It is likewise important for the state to ensure that statutory requirements are being adhered to in order to ensure both accountability to the public and integrity in our electoral process.

One such method of ensuring that accountability and integrity are found within the New Mexico Campaign Reporting Act (CRA) [NMSA 1978, §1-19-25 to §1-19-36]. The CRA requires the Office of the New Mexico Secretary of State (SOS) "to conduct a thorough examination of at least ten percent" (10%) of the campaign reports filed during the campaign reporting year that follows each general election (See §1-19-32.1).

The purpose of this examination is to perform a spot check in order to determine whether any candidates, campaigns or political committees may have violated provisions of the CRA. This report is an explanation of the process and findings of the examination conducted by the SOS after the 2016 General Election.

The review process included an examination of 106 randomly selected candidates and political committees. The review included a variety of different violations of the CRA including, but not limited to, exceeding the contribution limits and violating the provisions set for permissible use of campaign funds. Out of the 106 reporting entities reviewed, the SOS identified ten entities with one or more potential violations, including some entities that were found as a result of cross referencing the 106 reports, which required the candidate or political committee to provide additional information, pay excessive funds to the public election fund, or amend reports. All entities except one responded to inquiries made by the SOS, and provided the required information and otherwise worked with the SOS to come into voluntary compliance with the CRA as needed.

Only one discrepancy found during the review remains outstanding. This case, involving an entity that potentially failed to register as a political committee, is being forwarded to the Office of the Attorney General for further review.

Random Report Selection and Report Review Process

In order to determine which reports would be reviewed, and pursuant to Section 1-19.32.1(A), a randomly-selected list¹ of 106 candidates and political committees was generated on November

28, 2016, utilizing a random report listing generator function available within the SOS's Campaign Finance Information System (CFIS) software.²

During 2016, there were about 6,702 campaign finance disclosure reports filed by 642 candidates running in the general election, 265 political committees, and 176 prior candidates that still have campaign funds and have not closed their campaign accounts.³

The SOS then conducted a semi-automated review of all reports submitted for the 2016 calendar year by the candidates and political committees included in the randomly-generated list. This review was "semi-automated" in that initial queries were run against the reports contained within CFIS to identify potential violations and then thoroughly reviewed by the SOS before being included in this report as a finding.

Compliance with the following requirements of the CRA were included in the review process conducted by the SOS:

- 1. Candidates failing to timely register their campaign committees to begin reporting in accordance with the provisions set forth in Section 1-19-26(E).
- 2. Political committees registered within ten days of raising or spending \$500 in accordance with Sections 1-19-26.1 and 1-19-34.
- 3. Candidates and political committees provided the name of their financial institution in accordance with Section 1-19-34(A)(3).
- 4. Candidates did not receive anonymous contributions in excess of the limits provided for in Section 1-19-34.
- 5. Candidates and political committees disclosed the required information regarding contributions and expenditures as set forth in Section 1-19-31.
- 6. Candidates and political committees did not receive contributions above the allowable limits provided for in Section 1-19-34.7.
- 7. Candidates and political committees met the requirements regarding permissible expenditures as provided for in Section 1-19-29.1(A).

The results outlined below are a result of the thorough examination conducted by the SOS following the 2016 General Election. Pursuant to Section 1-19-32.1(A), as part of this review the SOS must notify potential violators of the CRA that a possible discrepancy has been found in

their report(s), and must allow the individuals or entities identified to file a written explanation for the discrepancy within ten (10) working days of the notice.

After a written response is received, the SOS issues a "Notice of Final Action," which may include dismissal of the finding upon explanation or correction. It could also include a penalty, pursuant to Section 1-19-34.4.

This report includes all potential findings, the resolution or a summary of the response to the potential finding, and any unresolved discrepancies, which are required to be forwarded to the Attorney General's Office for further action.

Each section below will provide a description of the aspect of the review that was conducted and a list of the findings associated with that aspect of the review.

Findings of the 2016 Examination Process

Section 1. Candidates failing to timely register their campaign committees to begin reporting in accordance with the provisions set forth in Section 1-19-26(E).

No violations of this type were found in the sampling of reports reviewed.

Section 2. Political committees registered within ten days of raising or spending \$500 in accordance with Sections 1-19-26.1 and 1-19-34.

During a review of the entities identified on the random report listing, the SOS discovered a potential violation by the New Mexico Habitat Conservation Initiative (NMHCI) of Section 1-19-26.1, which requires a political committee to register and begin disclosure within ten days of receiving, contributing, or expending \$500.

During the 2016 election cycle, NMHCI donated a total of \$47,500 to several registered PACs and one candidate covered under the CRA (See Table 1).

In February 2016, NMHCI filed with our office as a corporation, but not as a political committee. Upon review of NMHCI's Article of Incorporation, NMHCI filed as a 501(c)4 domestic nonprofit corporation with a purpose that indicates it operates, to at least some degree, for a political purpose. NMHCI's Articles of Incorporation provide that it will:

"...(1) engage in the study and research of fish and wildlife and (2) develop and advocate for legislation, regulations, and government programs to protect the habitat of fish and wildlife." [Emphasis added]

Based upon the amount of money spent on donations and the purpose statement found in the Articles of Incorporation, it is possible that NMHCI may operate primarily for a political purpose, which requires registration as a political committee under the CRA.

On February 24, 2017, the SOS sent a letter to NMHCI requesting additional information in order to make a determination regarding the potential violation. As of the date of this report, the SOS has not received a response from NMHCI.

Since the SOS is unable to determine whether the entity should be registered as a PAC based upon the information currently available to our office, this unresolved discrepancy is being forwarded to the Attorney General's office for further review as required by Section 1-19-32.1(B).

Section 3. Candidates and political committees provided the name of their financial institution in accordance with Section 1-19-34(A)(3).

No violations of this type were found in the sampling of reports reviewed.

Section 4. Candidates did not receive anonymous contributions in excess of the limits provided for in Section 1-19-34.

No violations of this type were found in the sampling of reports reviewed.

Section 5. Candidates and political committees disclosed the required information regarding contributions and expenditures as set forth in Section 1-19-31.

No violations of this type were found in the sampling of reports reviewed.

Section 6. Candidates and political committees did not receive contributions above the allowable limits provided for in Section 1-19-34.7.

Pursuant to Section 1-19-34.7, candidates and political committees are subject to contribution limits. These limits are adjusted the day after each general election based upon the preceding two year's increase of the consumer price index published by the United States Department of Labor (See §1-19-34.7(D)).

During the 2016 election season, the limit for non-statewide candidates was \$2,500 for each election cycle. For statewide candidates and PACs, the limit was \$5,400 for each election cycle. Each candidate and political committee may receive up to the limit for each election, the primary and the general, from the same contributor. Table 2 includes reporting entities identified during the review that exceeded the contribution limits set during the 2016 election cycle.

Section 7. Candidates and political committees met the requirements for permissible expenditures as set forth in Section 1-19-29.1(A).

Section 1-19-29.1(A) provides for the limitations on use of campaign funds for entities covered by the CRA. The SOS reviewed the expenditures of the 106 entities included in the random review to determine whether the expenses appeared to be campaign related and otherwise compliant with the provisions of this section of the CRA. If the SOS was unable to determine whether an expenditure was compliant, a letter requesting additional explanation was sent to the reporting entity. The explanation provided by the candidate or political committee was then reviewed by the SOS in order to make a final determination regarding whether a violation was incurred as outlined in Table 3.

Other Findings

During the review of expenditures, the SOS found expenditures for items that were purchased for raffles (See Table 4). While this finding is not strictly a violation of the CRA and is not under the jurisdiction of the SOS, the SOS provides education to candidates and PACs based upon guidance received from the New Mexico Gaming Control Board (GCB) that indicates the Raffle and Bingo Act does not define political campaigns or committees as organizations eligible to hold raffles. We provided evidence of our findings along with the guidance provided by the GCB to the reporting entities and notified the Gaming Control Board as well.
