ORDER SETTING CONDITIONS OF RELEASE

Release on recognizance or unsecured bond:

Defendant's conditions of release:

The Court FINDS that the following conditions of release are the least restrictive conditions necessary to reasonably ensure the appearance of the defendant as required and the safety of any other person and the community. The defendant shall not violate any federal, state, or local, criminal law and shall:

[X] obey all federal, state, tribal, and local laws, statutes, and ordinances

[X] not to possess firearms or dangerous weapons, which includes any device that is capable of expelling a projectile by action of an explosion;

[] not buy, sell, consume, or possess illegal drugs;

[] notify the court of any change of address;

[X] not leave the United States of America without written permission of the Court;

[] have an ignition interlock device installed on any vehicle the defendant may drive;

[] be on Electronic Monitoring – house arrest and abide by all conditions set by the court and by the electronic monitoring program, specifically house arrest;

be on Pre-Trial Services and abide by all conditions set by the court and pretrial services;
Reside at: (address) unless otherwise agreed by the court;

[] submit to drug and alcohol testing upon the request of Electronic Monitoring / Pre-Trial Services;

[] not leave the defendant's residence between the hours of __p.m. and __a.m. without prior permission of the court;

[] maintain employment, or, if unemployed, actively seek employment;

[] maintain or commence an educational program;

[X] other conditions: Defendant is permitted to have contact with potential witnesses only in the capacity laid out herein: In connection with the "Rust" movie and other related and unrelated business matters: provided, however, that Defendant is not permitted to discuss the accident at issue, or the substance of his or the witness's potential testimony in this case. "Related business matters" is designed to capture promoting the movie and other similar activities. "Unrelated business matters" is designed to capture other business relationships between Baldwin and any of the witnesses. The Defendant is permitted to continue to utilize Matthew DelPiano as his agent. Discussion about the incident is permitted with the witnesses who are named as civil codefendants only so long as such conversations are held exclusively in the presence of attorneys for civil litigation purposes. The Defendant will not directly or indirectly solicit witnesses or members of the cast and crew to participate in the documentary with Moxie films or to obtain statements regarding safety on the "Rust" set outside of standard investigative procedures.

Release on secured bond:

[] The Court FINDS that release on non-monetary conditions will not reasonably assure the appearance of the defendant. In making this determination, the Court finds the following particularized factors require imposition of a secured bond in the amount set forth below:

Defendant's acceptance of conditions and promise to appear:

I understand that the Court may have me arrested at any time, without notice, to review and reconsider these conditions.

I understand that my conditions of release may be revoked and I may be charged with a separate criminal offense if I intimidate, or threaten a witness, the victim, or an informant, or if I otherwise obstruct justice.

I further understand that my conditions of release may be revoked if I violate federal, state, or local criminal law.

I agree to appear before the FIRST JUDICIAL DISTRICT COURT at such times and places required in this case by any court.

I understand that if I fail to appear as required, my bond may be forfeited and I may be prosecuted and sent to jail for the separate offense of failure to appear. I agree to comply fully with each of the conditions imposed on my release and to notify the court promptly in the event I change the address indicated below.
