#### FINES AND FEES – PAYMENT OPTIONS

#### FREQUENTLY ASKED QUESTIONS:

#### Can I make payments on my fines and fees?

Yes, you have until the due date noted on your Addendum to pay off the balance. There is no minimum payment due. The court will accept any amount of payment from you.

# Can I do community service for my fines and fees?

Yes, you are eligible to work community service for fines and fees. It is your responsibility to schedule your community service.

# How do I register for community service?

If you choose to complete your community service at one of the Weed and Litter Programs, you do not need to call and make an appointment. Report to the agency at 7:00 a.m., Monday-Saturday. (see location and schedule on attached maps)

If you choose to work at a court-approved non-profit agency, you must contact the agency and make arrangements to work (see attached court approved non-profit agency list).

#### Can I do both community service and make payments towards my fines and fees?

Yes, you can work some hours for community service and then pay the remaining balance, or vice versa. Any combination of community service and or monetary payment will be accepted.

#### How many hours of community service will I need to work to fulfill my obligation for my fines and

Any hours worked will be credited at Federal Minimum Wage. We strongly recommend you keep track of the community service hours you work.

#### I don't want to do community service at weed and litter, where can I go?

Attached is a list of the court-approved non-profit agencies and their specific requirements. You must call and schedule your service hours directly with them. You must complete the community service hours before the due date.

## What agencies can I go to?

Please see attached court-approved list. (see reverse side)

#### Can I complete my community service at more than one agency?

Yes, you can change the agency as long as you complete the community service hours by the due date.

## What paperwork do I need to present to the community service agency?

You must take your Addendum/Judgment & Sentence paperwork and a government approved identification card (ID). It is very important that you have your Addendum/Judgment & Sentence paperwork and a government ID with you when scheduling with an agency and when reporting for service hours.

## Can I get an extension on my fines and fees?

No, we are including an extension with the due date. Please understand that NO ADDITIONAL EXTENSIONS will be allowed after the due date.

#### How do I know that my payment obligation has been completed?

You can check the Metropolitan Court website (http://metro.nmcourts.gov/) or call 505-841-8151.

#### Is there a number I can call if I have questions about my fines and fees?

Yes, 505-841-8151.

Metropolitan Court has made it convenient for you to pay your fines and fees. If you are unable to pay the fines and fees, you have the option of completing community service at a one of the two Weed and Litter agencies or one of the other court-approved non-profit agency. It is your responsibility to ensure the fines and fees are paid by the due date. There will be NO PAYMENT EXTENSIONS. If fines and fees are not paid or community service hours are not completed by the due date, a warrant for your arrest may be issued with an additional \$100 warrant fee.
