Count 1: Involuntary Manslaughter, (007), on or about October 21, 2021, in Santa Fe County, New Mexico at the Bonanza Creek Ranch located at 545 Bonanza Creek Road, Santa Fe, New Mexico 87508 the above-named defendant did cause the death of Halyna Hutchins, committed in the commission of an unlawful act, to wit: Negligent Use of a Deadly Weapon, contrary to 30-7-4 (a)(3), a fourth degree felony, contrary to NMSA 1978, Section 30-2-3(B)(1994).

IN THE ALTERNATIVE

Count 1: Involuntary Manslaughter, (006), on or about October 21, 2021, in Santa Fe County, New Mexico, at the Bonanza Creek Ranch located at 545 Bonanza Creek Road, Santa Fe, New Mexico 87508 the above-named Defendant did cause the death of Halyna Hutchins, committed in the commission of a lawful act, which might produce death in an

unlawful manner or without due caution and circumspection, a fourth degree felony, contrary to NMSA 1978, Section 30-2-3(B) (1994).

Count 2: Tampering with Evidence, (4230) on or about October 21, 2021, in Santa Fe County, New Mexico the above-named defendant did transfer narcotics to another person with the intent to prevent the apprehension, prosecution or conviction of herself, and the highest crime was a fourth degree felony, contrary to NMSA 1978, Section 30-22-5 (2003).
