These programs, which are overseen by the Transit and Rail Division of the NMDOT, help support general and specialized transportation throughout the State.

NMDOT fully understands that a well-integrated network of transportation options is a vital lifeline to expanding economic development in New Mexico.

I invite you to browse through this document and discover the many transportation options that are available to the people of New Mexico. I trust we are providing options that meet the need of your community and welcome your feedback on how we can increase the mobility of all New Mexicans.

## Introduction

**P**ublic transit is important to the vitality of individual communities and to the state as a whole. Many people are transit-dependent- they do not own or cannot operate a private vehicle because of their age, physical or mental ability, or financial status. They depend on public transit to access jobs, businesses, shopping, recreation, childcare, and medical and educational facilities.

Other people are transit riders by choice. Although they may be able to operate and afford a private vehicle, they choose to use public transit to help the environment, to reduce personal stress, to minimize their impact on air quality, to reduce wear and tear on their vehicle, and/or to save money.

This publication describes the public transit services offered in New Mexico and information regarding each of the transit providers. Persons needing transit service or more detailed information should contact these providers directly.

In 2023, as New Mexico transit agencies transition post-pandemic, some agencies have implemented or are piloting different service and fare structures. Some have temporarily reduced or adjusted service due to transit worker shortages that have been experienced nationwide, as well as in New Mexico. ***Users of the Transit Guide should visit the website of any transit service you plan to use for the most timely information.*** The web links are provided in this Guide.

## New Mexico Department of Transportation

**T**he Transit and Rail Division of the New Mexico Department of Transportation (NMDOT) administers NMDOT transit and rail programs.

The Division:

- Supports the development of transit and ridesharing as viable transportation choices in New Mexico.
- Administers federal transit grant funding and programs and provides technical and coordination assistance to public and private non-profit public transit systems.
- Administers federal transit grants and planning funds used by the state's larger municipalities and MPOs for public transit-related programs.
- Manages the NMDOT Park & Ride intercity bus service.
- In cooperation with the Rio Metro Regional Transit District, manages Rail Runner service.
- Conducts and participates in transit and rail planning activities.
- Assists local governments to establish Regional Transit Districts (RTDs) and assists the RTDs to plan, coordinate and implement service.
- Administers the NMDOT's railroad grade crossing safety improvement program.
- Administers the permitting program for requests to allow infrastructure projects to cross or use NMDOT-owned railroad property.

## Federal Transit Administration Grant Funding Programs

The NMDOT Transit and Rail Division administers various grants from the United States Department of Transportation's (USDOT) Federal Transit Administration (FTA) that supports both general and specialized public transportation programs in the state. These programs are named for the section of the federal transportation law that created them.



**Federal Transit  
Administration**

Congress establishes the funding for FTA programs through authorizing legislation that amends Chapter 53 of Title 49 of the U.S. Code. On November 15, 2021, President Biden signed the Infrastructure Investment and Jobs Act, reauthorizing surface transportation programs through Fiscal Year 2026.

Statewide, funding increased 34% from FY 2018 (\$54.5 million) to FY 2022 (\$73.5 million). See funding chart on page 4.

## Federal Transit Grant Programs

### FTA Sections 5303 and 5304 Programs - Metropolitan and Statewide Planning

Provides funding and procedural requirements for multimodal transportation planning in metropolitan areas and states that are cooperative, continuous and comprehensive, resulting in long-range plans and short-range programs of transportation investment priorities. Eligible activities include development of transportation plans and programs, planning, design and evaluation of public transportation projects, preparing technical studies related to public transportation. A 20% local match is required. Section 5304-funded studies:

- Rio Metro RTD Valencia County Transit Maintenance Facility Study
- Las Cruces Short Range Transit Plan
- North Central RTD Transit Service Plan Update
- North Central RTD Wage and Compensation Study
- North Central RTD Long Range Transit Study and Tribal Restoration Study

### FTA Section 5307 Program - Urbanized Area Formula

This program provides funding for transit operations and capital projects in urban areas with populations greater than 50,000 and less than 200,000, and provides funding for capital projects only in areas with greater populations. The federal share may not cover more than 50% of operations funding, and may not cover more than 90% of the cost of capital projects.

## Introduction

### **FTA Section 5339 Program - Grants for Buses and Bus Facilities**

This program makes federal resources available to states and designated recipients to replace, rehabilitate and purchase buses and related equipment and to construct bus-related facilities including technological changes or innovations to modify low or no emission vehicles or facilities. Funding is provided through formula allocations and competitive grants. A sub-program provides competitive grants for bus and bus facility projects that support low and zero-emission vehicles. An 80/20 federal/local match for capital purchases is required.

### **FTA Section 5310 Program - Enhanced Mobility for Seniors and Individuals with Disabilities**

This program utilizes funds to ensure transit access via capital investment for seniors and individuals with disabilities. An 80/20 federal/local match for capital purchases is required. Eligible projects must be included in a locally-developed coordinated human service transportation plan. ### **FTA Section 5311 Program - Formula Grants for Rural Areas**

This program provides planning, capital, operating and administrative assistance to public transportation initiatives in non-urbanized areas with populations under 50,000. The program aims to enhance access to health care, shopping, education, employment, public services, and recreation, to maintain, to develop and improve rural public transportation, to develop and support intercity bus service, and to provide for the participation of private transportation operators. Section 5311 funds must be matched by local funds. An 80/20 federal/local match is required for administrative, capital, and planning expenses, and a 50/50 match is required for operating expenses.



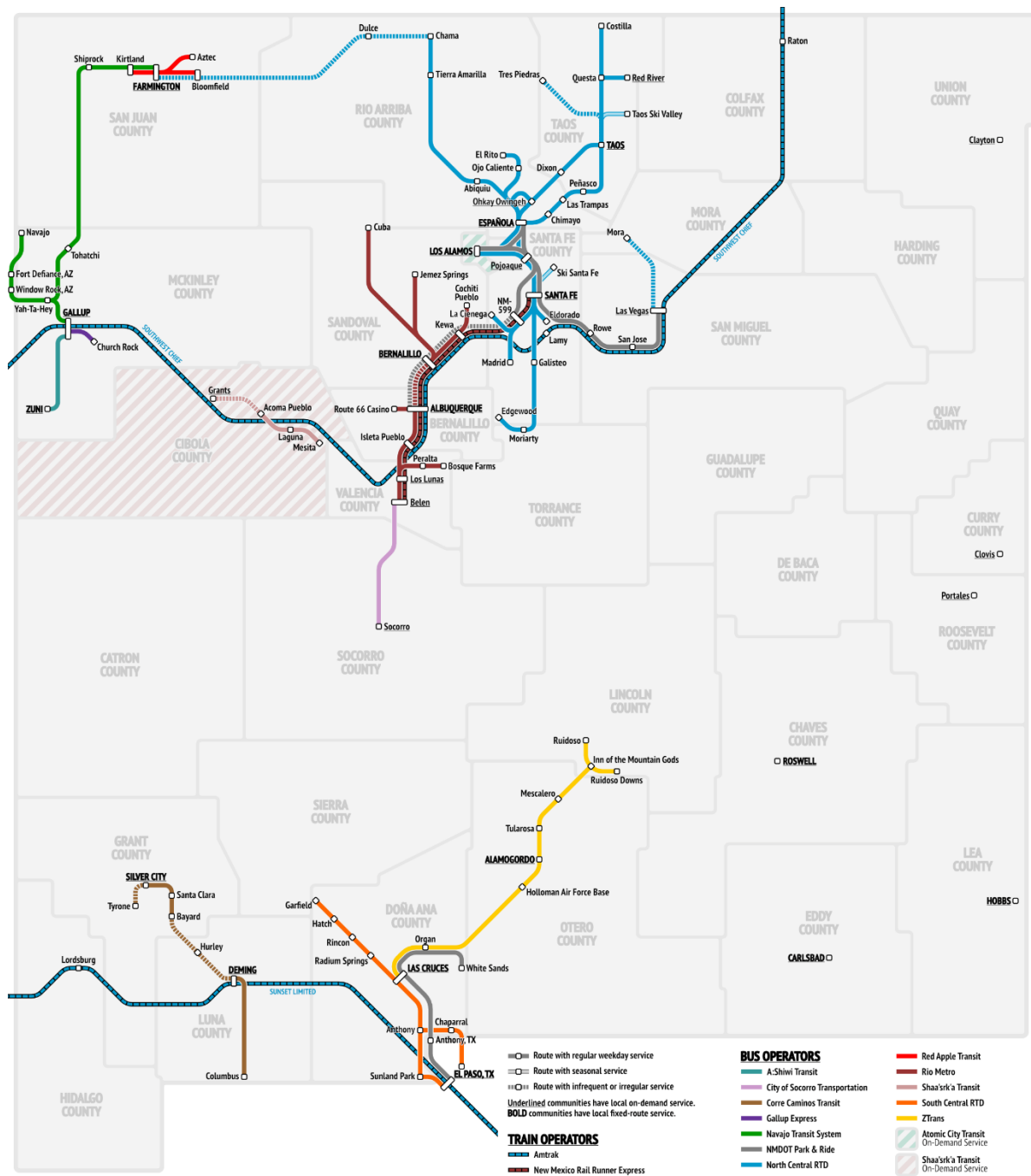

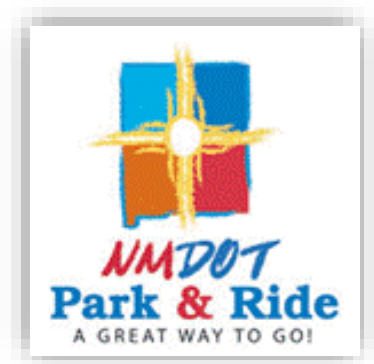

The NMDOT Park & Ride network, operated by the New Mexico Department of Transportation, provides express intercity bus service in northern New Mexico and in the Las Cruces region. Service is provided in the morning and evening peak periods on weekdays along seven intercity routes. Live tracking of Park and Ride buses is available at <http://nmdotparkandride.transloc.com/>.

#### New Mexico DOT Park and Ride Facts

- ❖ Low fares (averages 7 cents/mile)
- ❖ In 2022, the average passenger saved up to \$720 monthly by choosing Park & Ride over driving alone in their private vehicle (assuming 64-mile round trip, 72 cents per mile private vehicle operating and ownership cost, and a \$90 monthly pass)

#### NMDOT Park & Ride Facts

In FY 2022, NMDOT Park & Ride:

- ❖ Reduced traffic congestion by removing an estimated 3.4 million vehicle miles of travel from our busiest highways during the busiest commute hours
- ❖ Reduced carbon dioxide emissions (a Greenhouse Gas) by 1,641 tons
- ❖ Reduced gasoline consumption by 169,198 gallons.

With 120 bus departures daily on seven fixed routes and five shuttle routes, and 100,367 passenger trips provided in FY 2022, NMDOT Park & Ride is the State's fifth largest bus transit system. Since its inception, the service has provided over 4 million trips and driven over 128 million passenger miles without a fatality or serious injury.

The state fiscal year 2022 budget for NMDOT Park & Ride included \$6.9 million of state funds, \$400,000 in federal funds, \$528,983.30 from El Paso County, \$160,322.20 from Rio Metro RTD, \$301,806.70 of fare revenues and \$4,900 in advertising revenues.

## State Transit Services



NMDOT Park & Ride operates with 24 fifty-seven passenger buses, including four spare buses.

- **The Blue Route** provides eleven northbound trips and eleven southbound trips between Santa Fe and Los Alamos, also serving Pojoaque. Two afternoon trips from Los Alamos to the NM-599 Rail Runner Express Station.
- **The Green Route** provides thirteen roundtrips between Los Alamos and Española.
- **The Red Route** provides six roundtrips between Santa Fe and Española, also serving Pojoaque.
- **The Orange Route** provides three northbound trips and four southbound trips between Santa Fe and Las Vegas, also serving Rowe and San Jose.
- **The Purple Route** provides four round trips between Los Alamos and the NM-599 Rail Runner Express Station, as well as one trip from Albuquerque to Los Alamos in the morning.
- **The Gold Route** provides eleven eastbound trips and nine westbound trips between Las Cruces and El Paso, also serving Anthony.
- **The Silver Route** provides two round trips between Las Cruces and White Sands Missile Range.
- **The Rodeo Park Shuttle** meets three morning northbound arriving and three afternoon southbound departing New Mexico Rail Runner Express trains at the South Capitol Station, as well as most peak direction NMDOT Park & Ride Orange and Red Route buses.
- **The Anaya Complex Shuttle** meets three morning northbound arriving and three afternoon southbound departing New Mexico Rail Runner Express trains at the South Capitol Station.



- **The Santa Fe Place Shuttle** meets three morning northbound arriving and three afternoon southbound departing New Mexico Rail Runner Express trains at the NM-599 Rail Runner Express Station.
- **National Guard/Corrections Shuttle** meets three morning northbound arriving and three afternoon southbound departing New Mexico Rail Runner Express trains at the NM-599 Rail Runner Express Station.
- **The Purple Shuttle** meets the morning northbound Purple Route bus from Albuquerque at the NM-599 Rail Runner Express Station and proceeds to the South Capitol Station and the Santa Fe Depot.

Fares are \$3.00 one-way for all intercity routes except those that serve Española, which have fares of \$2.00 one-way. Monthly passes are available for \$90.00, or \$60.00 for Española routes. System wide monthly passes are also available for \$150.00, and are valid on all routes and the New Mexico Rail Runner Express. Fares for local connecting shuttle routes in Santa Fe are \$1.00 one-way; however, any valid NMDOT Park & Ride monthly pass or Rail Runner Express ticket is valid for travel on these routes.

New Mexico Rail Runner Express is a commuter train line that operates between Belen and Santa Fe, providing service to 15 stations in Valencia, Bernalillo, Sandoval and Santa Fe Counties. The 15 current stations in service are: Belen, Los Lunas, Isleta Pueblo, the Bernalillo County/International Sunport, Sandia Pueblo, Downtown Albuquerque, Montañó, Los Ranchos/Journal Center, Downtown Bernalillo, U.S. 550/Sandoval County, Kewa Pueblo, NM-599, Zia Road, Santa Fe South Capitol and Santa Fe Depot/Rail Yard. The Rail Runner Express currently operates 25 train trips on weekdays, 16 train trips on Saturdays, and seven train trips on Sunday. Trip planning for the New Mexico Rail Runner Express and all other Rio Metro services are available through Google Maps.

The New Mexico Rail Runner Express operates on a zone-based fare system. Fares are calculated based on the number of zones the train passes through between the origin and the destination stations. A full price roundtrip fare between Santa Fe and Albuquerque is \$10.00. Reduced fares are available for youth, students, seniors and people with disabilities. Monthly and annual passes are also available. Please consult the Rio Metro web site for updated fare, schedule and policy information.

## State Transit Services

Rail Runner serves as the spine of a regional transit network that includes Socorro, Taos, Los Alamos, Las Vegas, and Cuba. There are transit connections at most Rail Runner stations to local and regional bus services and commuter, casino, and university shuttles. At the Downtown Albuquerque station, located adjacent to the Alvarado Transportation Center, connections can be made to Greyhound bus service, Amtrak's Southwest Chief, UNM Campus and Hospital shuttles, as well as many ABQ Ride bus routes. ABQRide provides connections to the International Sunport from both the Downtown Albuquerque and Bernalillo County stations. Other notable connections include NCRTD bus routes from Santa Fe stations to Taos and Los Alamos and the Socorro Shuttle from the Belen Rail Runner station.

Following a temporary service shutdown and subsequent period with limited weekday-only service during the COVID-19 pandemic, Rail Runner resumed full service in May, 2021. Ridership has been increasing regularly since then, and has returned to about 70% of pre-pandemic levels.

Rail Runner has carried a total of 13.3 million passenger trips since service began on July 14, 2006. In November 2022, total monthly Rail Runner ridership was 40,229 and average weekday ridership was 1,688.

### NM Rail Runner Express Benefits

In FY 2019, Rail Runner:

- ❖ Reduced traffic congestion by removing an estimated 24.8 million vehicle miles of travel from our busiest highways during the busiest commute hours
- ❖ Reduced carbon dioxide emissions (a Greenhouse Gas) by 5,900 tons
- ❖ Reduced gasoline consumption by 680,000 gallons.

The Regional Transit District Act, passed in 2003 by the New Mexico Legislature, authorized the creation of Regional Transit Districts (RTDs) in New Mexico, and outlined their powers and duties. This was followed up the next year by the Regional Transit Gross Receipts Tax Imposition Legislation, which allows member communities of an RTD to increase Gross Receipts Taxes to support transit. Four RTDs have been certified in New Mexico.



### ***North Central Regional Transit District***

The North Central Regional Transit District (NCRTD) includes the counties of Los Alamos, Taos, Rio Arriba, and Santa Fe, as well as the Eight Northern Pueblos and Jicarilla Apache Nation. The RTD was certified in 2004 and began service in 2007; in 2008 voters approved a Gross Receipts Tax of 1/8 of one percent. NCRTD operates 26 fixed and flex routes, all of which are fare-free, and two on-demand microtransit zones.

New Mexico Rail Runner Express is a commuter train line that operates between Belen and Santa Fe, providing service to 15 stations in Valencia, Bernalillo, Sandoval and Santa Fe Counties. The 14 current stations in service are: Belen, Los Lunas, Isleta Pueblo, the Bernalillo County/International Sunport, Sandia Pueblo, Downtown Albuquerque, Montaño, Los Ranchos/Journal Center, Downtown Bernalillo, U.S. 550/Sandoval County, Kewa Pueblo, NM-599, Zia Road, Santa Fe South Capitol and Santa Fe Depot/Rail Yard.
